Acceptable Use Agreement



At Mt Eliza Primary School we support the right of all members of the school community to access safe and inclusive learning environments, including digital and online spaces. This agreement outlines the School's roles and responsibilities in supporting safe digital learning, as well as the expected behaviours we have of our students when using digital or online spaces.

At our School we:

- Have a Student Wellbeing and Engagement Policy that outlines our School's values and expected student behaviour. This Policy includes online behaviours;
- Have programs in place to educate our students to be safe and responsible users of digital technologies;
- Educate our students about digital issues such as online privacy, intellectual property and copyright;
- Supervise and support students using digital technologies for school-directed learning;
- Use clear protocols and procedures to protect students working in online spaces. This includes reviewing the safety and appropriateness of online tools and communities, removing offensive content at earliest opportunity, and other measures;

- Provide a filtered internet service, at school, to block inappropriate content. We acknowledge, however, that full protection from inappropriate content cannot be guaranteed.
- Use online sites and digital tools that support students' learning;
- Address issues or incidents that have the potential to impact on the wellbeing of our students;
- Refer suspected illegal online acts to the relevant Law Enforcement authority for investigation;
- Support parents and caregivers to understand safe and responsible use of digital technologies and the strategies that can be implemented at home. The following resources provide current

STUDENT DECLARATION

When I use digital technologies, I communicate respectfully by:

- always thinking and checking that what I write, or post is polite and respectful;
- being kind to my friends and classmates and thinking about how the things I do or say online might make them feel;
- not sending mean or bullying messages or forwarding them to other people;
- creating and presenting my own work, and if I copy something from online, letting my audience know by sharing the website link to acknowledge the creator.

When I use digital technologies, I protect personal information by being aware that my full name, photo, birthday, address and phone number is personal information and is not to be shared online. This means I:

- protect my friends' and other people's information in the same way;
- will not upload any images or videos where our school uniform is visible via social media or online video platforms/forums;
- protect my passwords and don't share them with anyone except my parents and teachers;
- only ever join spaces with my parents or teacher's guidance and permission eg chat and gaming forums;
- never answer questions online that ask for my personal information;
- know not to post three or more pieces of identifiable information about myself.

Acceptable Use Agreement



- When I use digital technologies, I respect myself and others by thinking about what I share online. This means I:
 - stop to think about what I post or share online;
 - will not attempt to log into the network or online service with a username or password of another person;
 - will not treat others in harmful, inappropriate or hurtful ways online;
 - speak to a trusted adult if I see something or someone that makes me feel upset online, or if I need help;
 - will only take and share photographs or sound or video recordings when others are aware the recording is taking place and have provided their explicit consent;
 - only use spaces or sites that are appropriate, and if I am not sure I ask a trusted adult for help;
 - will not share or post the link (or password) to video conferencing meetings with others;
- speak to a trusted adult if I see others participating in unsafe, inappropriate or hurtful online behaviour;
- meet the stated terms and conditions for any digital or online tool which includes age restrictions;
- will not deliberately search for something rude or violent;
- turn off or close the screen if I see something I don't like and tell a trusted adult;
- am careful with the equipment I use.

At school we/I have:

- discussed ways to be a safe, responsible and ethical user of digital technologies.
- presented my ideas around the ways that I can be a smart, safe, responsible and ethical user of digital technologies.
- I will use this knowledge at school and everywhere I use digital technologies.

SIGNATURE OF AGREEMENT:

I understand and agree to comply with the terms of acceptable use and expected standards of behaviour set out within this agreement. This Acceptable Usage Agreement applies when digital devices and technologies are being used at school, for school-directed learning, during school excursions, at camps and extra-curricular activities.

I understand that there are actions and consequences established within the school's Student Wellbeing and Engagement Policy if I do not behave appropriately. I understand that breaches of this policy can result in a number of consequences which will depend on the severity of the breach and the context of the situation. This may include removal of digital technology privileges within the school.
