SUN PROTECTION POLICY

PURPOSE

The purpose of this policy is to support sun protection behaviours at Mt Eliza Primary School to minimise risk of health problems from sun overexposure, including skin cancer.

This policy provides guidelines to:

- support staff and students to use a combination of sun protection measures when UV index levels are 3 or above (generally mid-August to the end of April in Victoria)
- ensure that there are outdoor environments that provide adequate shade for students and staff
- ensure students are encouraged and supported to develop independent sun protection skills to help them to be responsible for their own protection
- support our school's strategies to meet its duty of care and occupational health and safety obligations to minimise harmful UV exposure and associated harm for students and staff.

SCOPE

This policy applies to all school activities on and off-site, including camps and excursions. It is applicable to all students and staff.

POLICY

Overexposure to the sun's ultraviolet (UV) radiation can cause health problems including sunburn, damage to skin and eyes, and an increased risk of skin cancer. UV damage accumulated during childhood and adolescence is strongly associated with an increased risk of skin cancer later in life.

UV radiation:

- cannot be seen or felt
- can be reflected off surfaces such as buildings, asphalt, concrete, water, sand and snow
- can pass through light clouds
- varies in intensity across the day and the year (highest from mid-August to the end of April in Victoria)
- peaks during school hours.



Sun safety is a shared responsibility and staff, parents and students are encouraged to implement a combination of sun protection measures whenever UV levels reach 3 or above. Information about the daily local sun protection times is available via the free SunSmart app, or at sunsmart.com.au or bom.gov.au.

Mt Eliza Primary School has the following measures in place for all outdoor activities during the daily sun protection times to help reduce the risk of overexposure to UV radiation for staff and students.

Shade

Mt Eliza Primary School provides sufficient options for shelter and trees to provide shade on school grounds, particularly in places such as:

- outside the canteen
- the discovery play and learning area
- outdoor eating areas
- the courtyard
- Gaga Pit and rear oval
- Over Prep Playground
- Shade sails adjoining the oval stage

Students are encouraged to use available areas of shade when outdoors during peak sun protection times, particularly if they do not have appropriate hats or outdoor clothing.

When building works or grounds maintenance is conducted at Mt Eliza Primary School that may impact on the level of shade available to staff and students, a review of the shaded areas available will be conducted and further shading installed as appropriate.

Sun protective uniform/clothing

Mt Eliza Primary School's uniform or dress code includes sun-protective clothing, including:

- shirts with a collar and/or high necklines
- tops with sleeves
- a broad brimmed hat

Mt Eliza Primary School's uniform or dress code applies on and off-site unless otherwise advised. When students are not required to wear school uniform (such as school camps, free dress day), Mt Eliza Primary School will ensure steps are taken to encourage students to wear sun-protective clothing whenever UV levels reach 3 and above.

Hats

From the second Monday of August to 30 April, all students **must** wear a sun protective hat that shades the face, neck and ears for all outdoor activities. Hats may also be worn for all outdoor activities outside of the August to April time period, by parent or student choice. Students must wear the official Mt Eliza Primary School board-brimmed school hat, available from the school uniform shop, which protects the face, head, neck and ears when outdoors. Hats brought from home are not permitted. Students who are not wearing the Mt Eliza Primary School broad-brimmed hat will be asked to use available areas of shade outside the library during outdoor play times.



Sunscreen

Mt Eliza Primary School encourages all staff and students to apply SPF30 (or higher) broad-spectrum, water-resistant sunscreen daily whenever UV levels reach 3 and above. Sunscreen should be applied at least 20 minutes before going outdoors, and reapplied every two hours (or more frequently if sweating or swimming).

Students and staff are reminded and encouraged to bring their own SPF30 (or higher) broad-spectrum, water-resistant sunscreen to school.

Mt Eliza Primary School has strategies in place to remind students to apply sunscreen before going outdoors including reminders by the classroom teacher and we include reminders about pre-applying sunscreen for excursions and camps in the event communication.

Curriculum

Students at our school are encouraged to make healthy choices. They are supported to understand the effects of sun exposure and are encouraged to be involved in initiatives to promote and model sun protection measures to the whole school. Mt Eliza Primary School will address sun protection and UV safety education through regular whole school reminders of our Sun Protection policy and as part of content taught in Health and Physical Education as per the Victorian Curriculum.

Staff role-modelling and OHS

Staff are encouraged to access resources, tools, and professional learning to enhance their knowledge and capacity to promote sun smart behaviour across the school community.

UV radiation exposure is considered as part of our school's risk management and assessment for all outdoor events and activities, i.e. UV radiation protection strategies are included in school camp activities, excursions, sports days and interschool sports events.

Families and visitors

Families and visitors participating in and attending outdoor school activities are encouraged to:

- wear a sun-protective hat, covering clothing and, if practical, sunglasses;
- apply SPF30 (or higher) broad-spectrum, water-resistant sunscreen; and
- seek shade whenever possible when outdoors.

Community engagement

Sun protection behaviour is regularly reinforced and promoted to the whole school community through newsletters, school website/intranet, staff and parent meetings, school assemblies, student and teacher activities and at student enrolment/new staff orientation.

Families, students and staff are provided with information, ideas and practical strategies to support UV safety at school and at home. Mt Eliza Primary School may provide information through newsletters, Compass, school website and school assemblies.
