

# **Discipline**

## **Policy**

## Rationale:

Positive and responsible student behaviour is essential to the smooth running of the school, to the achievement of optimal learning opportunities, and to the development of a supportive and cooperative school environment.

## Aims:

- To build a school environment based on positive behaviour, mutual respect and cooperation.
- To manage poor behaviour in a positive and professional manner. Corporal punishment of any kind is not part of the school ethos and will not be used in the school.
- To establish well understood and logical consequences for inappropriate student behaviour.

## Implementation:

- Our school will develop, through a process of wide community consultation, a comprehensive Student Engagement Policy based upon 'The Student Engagement and Inclusion Guidance', which outlines amongst other things, agreed behavioural expectations, responsibilities of all parties and management strategies.
- MEPS Social, Emotional and Wellbeing scope and sequence curriculum will be used as a basis for developing a positive learning and behaviour environment in the school.
- Our Engagement Policy will place significant emphasis on the development and recognition of positive behaviours.
- All student behaviour will be consistently followed up according to the school wide behaviour management plan (Appendix 1).
- Student individual academic reports will include details regarding student behavioural achievement.
- Peer mediation and peer counselling will be key strategies employed to guide and develop student behaviour.
- Whole school rules will be negotiated with the Student Representative Council.
- We will provide a wide range of preventative options (Appendix 2) for students including sporting and lunchtime clubs.
- Positive student behavioural achievement will appropriately recognised, for example student awards at assembly.
- An up-to-date database of student behaviour will be maintained using our Sentral database.
- All staff will undertake ongoing professional development on student engagement, behaviour and discipline management.
- The school curriculum will include units on resilience, peer pressure, positive choices, bullying, conflict resolution and leadership.
- Students experiencing difficulty achieving positive behavioural outcomes will undertake individualised behaviour management programs focussing upon agreed goals.
- Consequences for ongoing inappropriate behaviour will involve a graded series of sanctions including, counselling, restorative practice, withdrawal, lunchtime detention, loss of privileges or suspension but will never involve corporal punishment (Appendix 1- Behaviour Management Plan).
- Parents will be kept informed, and actively encouraged to assist in the development of their children's behavioural performance.
- Communication emphasising positive behaviours will be communicated via letters home, assemblies, newsletters, local paper and other appropriate forums.

This policy will be reviewed as part of MEPS two –year review cycle in April 2018
